Question 13

Q: Does the imprint on the samples need to be in white?

A: No. There is no specific imprint color requested for the samples to be received with the bid.

Question 14

Q: If I cannot get a custom green pencil sample delivered by the bid/sample due date, are virtual samples acceptable?

A: Yes. Virtual samples are ACCEPTABLE for the PMS 361 Green pencil sample only. Please note, a physical sample of the blue pencil that matches PMS 286 must be sent in with each bid in addition to a virtual sample of the PMS 361 green pencil sample. The samples submitted with bids must have imprints but NOT necessarily SCEL imprints.

Question 15

Q: Will you accept suppliers stock colors that are closely matched to PMS 286 and 361 or will this need to be a custom job with exact PMS matching?

A: SCEL will accept a supplier's stock color that is closely matched to the PMS 286 blue; however, the PMS 361 green MUST be a custom match that is exact.

See Question 14 for acceptable sample colors and imprints. For pre-production proofs and final production, substitutions in colors will MOT be accepted and SCEL artwork must also be on the actual pre-production proofs and final production.

Question 16

Q: Was the last pencil order of this kind, quantity, awarded as exact PMS color match or awarded based on supplier's stock colors?

A: The last pencil order awarded of this kind and quantity was based on the following. The blue pencil was a supplier's stock color that was closely matched to the PMS 286 blue and the green pencil was a custom match to PMS 361 that was an exact match.

Question 17

Q: Was the last pencil order of this kind, quantity, supplied domestically or overseas?

A: The last order of pencils was supplied domestically.

Question 18

Q: What font and typesize is requested for the imprint?

A: The font for the imprint must be a Sanserif font (Helvetica or similar) and the image area is 2 ½"L x 2/8"H.
