**Question 6**

**Q: Will a recent CV with references suffice for additional information?**

**A: Yes, a recent CV with references is sufficient.**

**Question 7**

**Q: Is the current deadline for submission this Monday, October 24 end of the day?**

**A: No, as posted on page 1 of the solicitation, 11 a.m. on Monday, October 24, is the deadline for receiving questions. An amendment containing the answers to the questions will be posted on Tuesday, October 25. Vendors have time to**

view Amendment Number 5 with questions 5-7 and the answers and adjust their submission before the deadline to submit offers on **Thursday, Nov. 3, 2016, at 4 p.m. local time.** (Not a public bid opening)

Vendors should monitor the website to check for amendments and will need to acknowledge they had the opportunity to read any amendments posted when sending their submission. There are several ways to acknowledge an amendment. By identifying the amendment number and date in the table 1) under ACKNOWLEDGMENT OF AMENDMENTS in the middle of page 2, or 2) at the end of each amendment posted vendors acknowledge receipt of amendments. Vendors may also 3) sign and return the amendment or 4) acknowledge by letter.
