Vendor Questions and Answers Issued Thursday, July 27, 2017

Question 1

- Q: Do you offer price tabulations of previous similar bids?
- A: This is the first procurement solicited by South Carolina Education Lottery containing a "Cooler Cling," so there are no previous bid tabulations to refer to for the Cooler Cling portion of the bid soliciation.
 - 1) Two recent <u>Window Cling</u> purchases:
 - i) In August 2015, a solicitation for 4,000 Window Clings was awarded to Premier Graphics in the amount of \$7,760 with shipping, but not including taxes.
 - ii) In December 2016, King International Corp. won the award in a solicitation for 4,000 Window Clings. The amount of the winning bid was \$7,720 including shipping, but not including taxes.

2) The specifications in the <u>earlier procurements</u> of Window Clings <u>only</u> stated:

- Material: 4 mil clear repositionable vinyl with barrier white film
- **Color:** 4-color process, double-sided (4/4). The same art appears on both sides.
- **Ink/Process:** UV screen; colors reverse printed on clear repositionable vinyl with white opaque barrier film; laminated; then colors printed on the barrier film.
- Bleed: All sides.
- Adhesive: Low tack removable adhesive on one side. Adhesive will stick to glass. (Spec GF's 114 low tack trans mount or similar product.)

3) The specifications for the <u>current solicitation</u> containing both Window Clings and Cooler Clings states:

- Print Process: Window Clings: Print 4/4 on a total opaque (i.e., blockout or light fast) white synthetic material, apply either gloss film lamination or gloss UV coating to one side. Apply clean removable adhesive to the other side. UV offset with fade resistant inks. Adhesive (TWD) for less than a year: EZ Stick from PLC; Adhesive (MM/PB) for more than a year: Products from General Formulation, Flexcon, 3M, Transcendia. Cooler Clings: Print 4/0 plus gloss UV coating to one side. Print on white pressure sensitive synthetic material with clean removable adhesive. UV offset with fade resistant inks.
- Material:The Walking Dead®:(Delivery no later than 11 a.m. local time on Friday, August 25, 2017)<u>Window Clings:</u>(The same art appears on both sides, in field less than a year.)Paper:8mil, transblock with EZ Stick AdhesiveInk/Process:4cp + Gloss UV Coating / 4cp + Adhesive with liner; UV offset with fade resistant inks

<u>Cooler Clings:</u> (The art appears on the front side only, in field <u>less than</u> a year.) Paper: 3.4 Mil White Low Tack PVC Vinyl, low tack Clean Removable Adhesive Ink/Process: 4/0 (UV CMYK); UV offset with fade resistant inks Finishing: <u>Cut to Shape/Die Cut</u>

Mega Millions[®]/Powerball[®]: (Delivery no later than 11 a.m. local time on Fri., Sept. 22, 2017) <u>Window Clings:</u> (The same art appears on both sides, in field for <u>more than</u> a year.) Paper: 8mil, transblock with Concept 114/113 Adhesive Ink/Process: 4cp+ Gloss UV Coating / 4cp + Adhesive with liner; UV offset with fade resistant inks

Finishing: The Walking Dead[®] Cooler Clings will be <u>Cut to Shape/Die Cut</u>.

- Color:Window Clings:4/4; Bleed: Yes, all sides.Cooler Clings:4/0; Bleed: Yes, all sides.
 - 4) <u>Vendors will note that aside from the added Cooler Cling, the previous bid amounts shown</u> in A: 1) and 2) above do not include Cooler Clings or the possible increased costs of the new substrate listed in A: 3). The current solicitation requests different substrates and adhesives based on the anticipated time the different clings will remain in the field.
